- 13. The audit will be done at the Head Office at P-3, C.I.T. Scheme VII-M, Kankurgachi, Kolkata 700054 and Regional Office at Dagapur Complex, P.O. Pradhan Nagar PIN-734403, District: Darjeeling.
- 14. The quoted audit fee shall be inclusive of all charges, taxes and duties and out of pocket expenses. However, GST will be payable extra as per norms.
- 15. Only CAG empanelled Auditor will be eligible to apply. The empanelment number is required to be mentioned in the application.
